RISKS ASSOCIATED WITH ELECTRONIC TRADING

Before you begin carrying out transactions with an electronic system, you should carefully review the rules and provisions of the stock exchange offering the system or of the financial instruments listed that you intend to trade, as well as your broker's conditions. Online trading has inherent risks due to system responses/reaction times and access times that may vary due to market conditions, system performance and other factors and on

which you have no influence. You should be aware of these additional risks in electronic trading before you carry out investment transactions.

RISKS ASSOCIATED WITH FUTURES TRADING

Futures transactions involve high risk. The amount of the initial margin is low compared to the value of the futures contract, so transactions are "leveraged" or "geared". A relatively small market movement has a proportionately larger impact on the funds that you have deposited or have to pay: this can work both for you and against you. You may experience the total loss of the initial margin funds as well as any additional funds deposited in the system. If the market develops in a way that is contrary to your position or if margins are increased, you may be asked to pay significant additional funds at short notice to maintain your position. In this case, it may also happen that your broker account is in the red and you thus have to make payments beyond the initial investment.

RISKS ASSOCIATED WITH FOREX TRADING

Trading in foreign exchange ("Forex") on margins entails high risk and is not suitable for all investors. Past performance is not an indication of future results. In this case, as well, the high degree of leverage can act both against you and for you. Before you decide to invest in foreign exchange, you should carefully assess your investment objectives, experience, financial possibilities and willingness to take risks.
